3. HAZARDS IDENTIFICATION

Extremely flammable.

PRESSURISED CONTAINER - increase in temperature to greater than 50C will cause internal pressure to rise potentially causing bursting/explosion.

4. FIRST AID MEASURES

INHALATION: Move the exposed person to fresh air at once. Keep the affected person warm and at rest. Get prompt medical attention. For breathing difficulties oxygen may be necessary.

INGESTION: Rinse mouth thoroughly. Drink plenty of water. Get medical attention.

SKIN: Wash the skin immediately with soap and water. Get medical attention if any discomfort continues.

EYES: Promptly wash eyes with plenty of water while lifting the eye lids. Continue to rinse for at least 15 minutes. Get medical attention if any discomfort continues.

5. FIRE FIGHTING MEASURES

EXTINGUISHING MEDIA: Use: Powder. Dry chemicals, sand, dolomite etc. Water spray, fog or mist.

SPECIAL FIRE FIGHTING PROCEDURES: Containers close to fire should be removed or cooled with water. Use water to keep fire exposed containers cool and disperse vapours.

UNUSUAL FIRE & EXPLOSION HAZARDS: Aerosol cans may explode in fires.

6. ACCIDENTAL RELEASE MEASURES

PRECAUTIONS TO PROTECT ENVIRONMENT: Any spillage needs to be contained and not allowed to enter water courses

SPILL CLEANUP METHODS: Wear necessary protective equipment. Extinguish all ignition sources. Avoid sparks, flames, heat and smoking. Ventilate. If leakage cannot be stopped, evacuate area.

7. HANDLING AND STORAGE

USAGE PRECAUTIONS: Keep away from heat, sparks and open flame. Avoid spilling, skin and eye contact. Ventilate well, avoid breathing vapours. Use approved respirator if air contamination is above accepted level.

STORAGE PRECAUTIONS: Aerosol cans: Must not be exposed for direct sunlight or temperatures above 50°C.
